

# JUSTICE vs. IMPUNITY

### Thursday, February 21, 2019 • Southwestern Law School

On July 18, 1994, terrorists bombed the AMIA (Asociación Mutual Israelita Argentina) in Buenos Aires, the central offices of the Argentine Jewish community, killing 85 people and injuring hundreds more. No one has ever been held criminally accountable for the crime. A former Argentine President, the original judge in the case and other senior Argentine officials are now on trial for participating in a cover-up, and a second Argentine President has been indicted for allegedly halting investigations into Iranian participation. In 2015, Alberto Nisman, the Argentine special prosecutor appointed to investigate the case, died of an alleged suicide, now presumed to be murder, just two days before he was scheduled to report to Congress on his investigation.

Southwestern's symposium includes leading attorneys, professors and Jewish Community leaders from Argentina and the United States who have participated in the investigations of the bombing, studied the failures in its investigations and dealt with the repercussions for the Argentine Jewish community of the bombing and resulting impunity.
