International Refugee and Asylum Law & Policy (2 units)

Track 2 students may select one or two one-unit courses from Track 1.

All students must take at least four units and may take up to six units.

COURSE DESCRIPTIONS

International Art Law (1 unit)

Examines international legal issues of art as creative endeavors, articles of commerce, and cultural artifacts. We will examine sales, dealer/auctioneer duties; sales and import taxes; recovery of plundered artworks; and copyright (and other) protections.

International Entertainment Law (2 units)

Provides an overview of the international legal issues when representing clients in music, publishing, film, etc. Topics include rights acquisition, celebrity name and likeness, fans' rights, IP and other protections, business/contract issues, censorship, and professional responsibility.

International Music Law (1 unit)

Compares key differences in the business and legal issues between the recorded music industry of the United States and other countries, including record deals, producer agreements, and other agreements governing creative relationships.

Negotiating and Drafting International Entertainment Contracts (2 units)

Provides a foundational understanding of the entertainment industry in a global marketplace, key players, various negotiation styles, and transactional agreements. Students will draft provisions and whole contracts for professor feedback.

International Refugee and Asylum Law & Policy (2 units)

Introduces fundamentals of refugee and asylum law, protections, and the underlying policies. Focus on women and children escaping gang violence and gender-based harm. Explores what leads people to flee and countries' response to those seeking refuge.

The Law Of, In, and About War (2 units)

Introduces fundamental principles of the laws governing battlefield conduct of hostilities (the Hague tradition) and treatment of those caught in war's cross-hairs (the Geneva tradition). A blended approach requires applying assigned reading to contemporary conflicts.

HOW MUCH WILL IT COST?

Application Fee	\$250

Housing and Materials	\$3,850

Tuition and fees paid to Southwestern Law School (\$9,850) will cover:

- ◆ Tuition and fees for four to six units
- ◆ Private “en suite” dorm room (e.g., private shower, toilet, and complimentary wifi)
- ◆ Breakfast in the dorm dining room
- ◆ Assigned books and reading materials
- ◆ Global travel insurance
- ◆ Opening-day London lunch and excursion, Farewell Dinner Party, and several other program excursions

Students must bear the following costs, which are not included in the program tuition or fees:

- ◆ Airfare to and from London
- ◆ Lunch, dinner, snacks, and drinks (unless specifically noted above)
- ◆ Transportation in London (except for certain excursions)
- ◆ Entertainment
- ◆ Travel expenses for weekend, out-of-London trips
- ◆ Personal items, including toiletries, clothes, and souvenirs

Prices in London

- ◆ Students should estimate that purchases in London will cost them more than what they would cost in the U.S. and budget accordingly.
- ◆ Before traveling, check the conversion rates between the US dollar and the British pound.

TUITION REFUND POLICY

Students who withdraw from the program or request a class change must notify Southwestern in writing as early as possible. Students who withdraw before the first day of the summer program may receive a 100% credit of charged tuition, with the exception of the application fee, the reservation fee, and the housing and materials fee. Thereafter, a refund for tuition is pro-rated on a daily basis. After 60% of the program is completed, students will not be entitled to any refund.

Students who withdraw from the program before the program commences due to a course cancellation, significant change, or the cancellation of the program, including cancellation because of a U.S. State Department travel warning or alert, will be refunded all monies advanced within twenty days after the cancellation or withdrawal.

Students who withdraw after the first day of classes due to a course cancellation, significant change, or termination of the program, including termination because of a U.S. State Department travel warning or alert, will be refunded fees paid except for the housing and materials payments utilized before the date of termination or withdrawal.
