Kathryn Campbell, J.D. is Professor of Legal Analysis, Writing, and Skills at Southwestern Law School in Los Angeles. She taught Legal Skills and other courses at California Western School of Law for seven years before moving to Los Angeles and to Southwestern in 2015.

Professor Campbell practiced law for 25 years before coming to the academy full time. She is the former Deputy Director of Michigan's Department of Human Services, and former Director of Bay County's Public Defender's Office. She has taught theater, communication, legal skills, human rights, civil litigation, and criminal justice at undergraduate and law schools.

Campbell studied voice at New England Conservatory, and theater at the National Theater Institute. She performed at theaters throughout the nation before becoming an attorney. Before Michigan's Governor appointed her to the Department of Human Services, Campbell defended and then prosecuted child abuse and juvenile delinquency cases.

Campbell presents world-wide on teaching legal writing and skills, pedagogy, human communications, peacemaking, and human rights. Among many meetings, she has presented regularly at Legal Writing Institute and Global Legal Skills Meetings.

Campbell is the founding Secretary of the Southwestern Inn of Court, and a Director of Slave Free Today--an NGO whose journal is a nexus of critical thought, to combat human enslavement and trafficking. She has served on many charitable, educational, and public service boards, and numerous Gubernatorial and State Supreme Court commissions, transition teams, and advisory committees. Among many editorial, writing, and leadership positions, she was an editorial board member of the Michigan Child Welfare Law Journal, chair of Michigan State Bar Children's Law Section, hearing referee for the Michigan Civil Rights Commission, founder/president of Mid-Michigan Children's Law Council, and has been described as "a formidable child advocate."

Professor Campbell entertains herself by writing prose, poems, and music, immersing herself in music and the arts, mentoring young people, exploring new adventures, working out, and spending time with beloved people and other creatures. Campbell's husband entertains the world singing and writing songs. Her personal-trainer/aerobatics performing artist/writer-linguist daughter lives in Portland Oregon.
