

EQUAL JUSTICE WORKS VIRTUAL CAREER FAIR

The Equal Justice Works Career Fair is the national recruitment event for public interest / public service career students. This annual recruitment event will see more than 3,300 interviews conducted for law students seeking summer or postgraduate positions in regions from across the country – e.g. East Coast, Mid-West, South/Deep South, Pacific Northwest and Southwestern states.

RESOURCES FOR PUBLIC-INTEREST AND PUBLIC-SERVICE STUDENTS

Southwestern has a deep commitment to public-service. The following resources are dedicated to supporting Southwestern students pursuing public-service career goals.

MARCH DEADLINES

PUBLIC-INTEREST LAW COMMITTEE AWARDS FOR GRADUATING STUDENTS

George & Katrina Woolverton Public Service Award. \$10,000 awarded to one graduating student in recognition of demonstrated extraordinary dedication to public interest law activities while at Southwestern.

Woolverton Family Public Interest Award.

S5,000 awarded to one graduating student in recognition of demonstrated exceptional dedication to public interest law activities while at Southwestern.

Public Interest Law Service Award. Given annually to a graduating student(s) in recognition of demonstrated significant dedication to public interest law activities while at Southwestern.

PUBLIC-SERVICE PLEDGE & COMMENCEMENT RECOGNITION

Graduating students who have completed a minimum of 75 hours of law-related service by deadline in their final year of study will be recognized at commencement ceremonies and a notation of Public-Service Program distinction placed on their academic transcripts.

JUDGE HARRY PREGERSON PUBLIC SERVICE FELLOWSHIPS

Southwestern's Judge Harry Pregerson (JHP) Public Service Fellows are selected students who demonstrate exceptional dedication to public service, and who are most likely to dedicate their legal careers to working on behalf of underserved communities and causes. Summer fellowship awards will be in the sum of S8,000 each to five (5) second-year students and of S5,500 each to five (5) first-year students.

PUBLIC-INTEREST LAW COMMITTEE SUMMER GRANT PROGRAM

The Public-Interest Law Committee (PILC) conducts fundraising activities throughout the academic year to support students in full-time, unpaid summer clerkships in the public-interest or public-service sectors. Students can apply for up to \$5,000 in funding.
